**CONTRACT**

**Agribusiness Council of Albania (KASH)**, the organizer of “Agribusiness 2011” Fair, September 23 - 25, 2011 at the Palace of Congresses in Tirana, Albania and The Company/Firm \_\_\_\_\_ with its seat at \_\_\_\_\_ and phone number \_\_\_\_\_ settle this agreement of participation at the fair. From September 23<sup>th</sup> – 25<sup>th</sup> September the Company/Firm \_\_\_\_\_ will have under its occupancy the surface of \_\_\_\_\_ m<sup>2</sup> with regard to the Fair’s project, and with the price of \_\_\_\_\_ EURO/m<sup>2</sup> for all the days of the duration. The price is 80 EURO/m<sup>2</sup> for interior space and 40 EURO/m<sup>2</sup> for outside space.

The price includes: the pavilion’s exhibiting surface, bordering by the panels according to the project, the general and the artistic illumination, floor covering by carpet, a table with three chairs, the electric connection of the pavilion (by a prolong), the overall commercial of the activity on TV, radio and papers, its own place and layout at the Fair’s catalogue.

KASH will take the responsibility of the exhibited products and the exhibitors during the Fair’s closing period of time, the rule and the normal proceeding of the activity, the sounding, providing the employees with badges, assistance during the press conferences, etc. The products’ acceptance and settling in pavilions will be carried out on September 21<sup>nd</sup>-22<sup>rd</sup> from 08:00 – 20:00 and September 22<sup>th</sup>, from 07:00 – 11:00. The firms and products organizing and settling in the respective pavilions will be performed in the collaboration and with the assistance of the Agribusiness Council.

The participating Company/Firm has the right of its own exhibition, settling of agreements and products’ trading. The material and products’ drawing from the Fairs’ premises should be terminated by September 26, 2011.

## **CONDITIONS OF PARTICIPATION**

1. The exhibitor's activity should take place only within the borders of the rented tent, where superficies from the floor up to 2.5 m of height is included. The remaining part of the room is under the possession of the fair's organizers. The violators will pay double price in case of occupation of this place.
2. The work time for the exhibitors is from 08:00 – 12:00. The fair is open to the visitors from 09:30 – 20:00.
3. The organizers could help with specialized staff such as arranging painters, interpreters/translators, hostesses, flower specialists, upon a preliminary request on a settled payment.
4. The organizers: provide the guard service from 20:00 – 08:00. From 08:00 - 20:00 the exhibitors themselves will take the responsibility of their own pavilions and the materials exhibited, and also the responsibility for the damage caused by them or their staff to the Fair's building, the floor, the walls or the rented materials.
5. The organizers will not keep any kind of responsibility for possible thefts or damages caused to the exhibitors in case of major forces.
6. The exhibitors pay the proper amount in the pre-established full value no later than seven days before the fair's opening.
7. The paid sum will not be refunded
8. The drawing of the materials exhibited should terminate one day after the fair's closure.
9. All the conflicts between the counterparts in this agreement will be resolved through the dialog; otherwise will be solved upon the laws.
